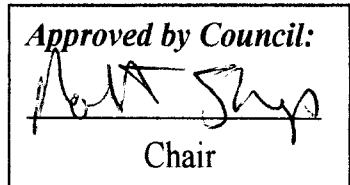


**HAMLET OF MOUNT LORNE ADVISORY COUNCIL
