Civic Addressing – This was originally intended as emergency response. Community members view it as more or less than that. Whether or not civic addressing can be used as a mailing address to receive parcels can be looked into, but it would involve public consultation.

Cemetery – more information on the management of site is needed, but the project is not at that stage yet. Denman Island site can be used as an example of natural burial. It would cost around \$4000 to do basic planning for this project. The acquisition of land could take up to a year. LMCA will not manage this project past the initial set up phase. There will need to be a board of directors for the cemetery.

c. Fire Smart -

Etienne circulated a document – unhappiness with the fire smarting plan – they would rather do it themselves. He raised his concerns with LMCA.

Due to high fire risk, Al would like support at the upcoming meeting to go forward with the Firesmart Plan. The purpose of firesmarting on one access roads is to allow extra time for evacuation in the event of a fire. We need to have more presentations in the community on fire prevention to educate citizens.

d. Electoral Boundaries Commission –

The commission took the decision to add a riding. YG is asking legal if they must approve this – because Yukoners were not briefed on it, and Southern Lakes was actively against it. YG believes this should only move forward with the ability of Yukoners to have more say on it.

- f. Mining on Annie Lake Road –
Red Ridge Mineral Exploration Proposal: Lisa submitted comments to YESAB on behalf of Council after talking to neighbours.
YESAB has completed its assessment of The Mount Anderson Mineral Exploration Proposal. It is recommending it for approval. It is currently before the decision body in EMR.
- g. RRC Wire Update –
Letters have not been written to White Pass, but there have been conversations with Chief Cardiff and Minister Pillai. CTRRC is calling for 1-2 day symposium June 2-3 at Tagish Community Center.
- h. NRCAN YG low carbon challenge and funding –
There are major roadblocks with this funding. The base level funding is 1 million and deadline for idea submissions is May 15. There is also money through YG for this. It will be presented at the AYC AGM and John will give the information to LAC's as well. The meeting of the LAC's might be a good place to talk about this. YG can do the leg work on any applications
